Getting Your First Job

You are only six months away from graduating from your lab school. You are into the last part of your rotation through departments It has been a long two- or four-year program and you may have to make a decision on where you want to live and where you work. You have been living at home these past few years commuting to school and rotations.

So, your first decision should be on where do you want to work and what department or shift you would prefer. Ow, some of this may have already been predetermined based upon the school and its affiliation with the hospitals.

As you know hospitals are affiliated, e.g., MedStar has Southern Maryland Hospital, Georgetown University Hospital and Washington Hospital Center. UMMS is affiliated with PGH & MC, LRH, BHC, Charles Regional Hospital, and Sibley Memorial Hospital in Hopkins has John Hopkins in Baltimore, Suburban Hospital in MD, and Sibley Memorial Hospital in NW DC. Then you have the Virginia consortium of facilities, Alexandria, Fairfax, MT Vernon, etc.

So, depending upon the school you enrolled in, the work experiences you have gotten may have been restricted to their affiliations with the medical centers. So, the easiest is to go to one of the facilities you had your rotations at. You're already familiar with the equipment and staff trainer and hopefully the manager.

Because these are the people who have a deciding actor on hiring you. So hopefully you've impressed them with your technical knowledge skills and your pleasant personality. So, your first step should be to set up a meeting with the lab manager about employment opportunities with their associations. You must be able to express your wishes for employment. A lot depends upon the availability of jobs and the work area or shift. They must be able to utilize your skills. Working the day shift for a new employee is pretty hard to get, so working the evening or night shift may be the only option to get in the door.

Another is your housing arrangements, If you are living at home I wouldn't make any changes to that at this point because if you are hired there is usually a 3-6 month evaluation period where you may be discharged without reason.

After this time making an effort to pay a minimal rental fee to your parents and purchasing groceries maybe monthly. If you have a roommate you need to see where they are working and if you both can still afford the housing arrangement. You also need to ensure you have renter's insurance.

Transportation requirements. Is the bus schedule going to meet your needs or will you have to get taxi service to and from work, another expense? Or will you need to purchase a used car to meet your needs. Again, more expenses, do you have a down payment for the car, bank account for maintenance and upkeep, auto insurance, and gas.

Good luck in obtaining your first job, hopefully you've impressed your new boss with your technical knowledge, skills and personality.
